- Nancy: loved how interactive it was; we should incorporate that with the future events; you have to know your history to know where you are going; what Kristian did was beautiful
- Re: this week’s event
 - Liz: the video was too short - 2mins only
 - Will reschedule the event when Johnny is better to complete the program
 - Editing the cadence of the meeting and dialogues
 - Bi-monthly or quarterly?
 - Arlene: every other month; so we do not feel rushed during meetings
 - Nancy: people need an outlet; every other month

4. Program for March 9, 2021

- Artist – Felicita Norris “Philosophy of Arts” – on schedule
 - Liz: gave bio; will give headshot
 - Jo will make flyer for social media by end of the week

5. Mural - On-going project planning/project

- Locate the first location
 - Arlene/Liz: Serramonte Mall is open for discussion; Marie says JCPenney;
 - Dorie: not sure if the wall is permanent
 - Nancy: who has say in what is put on the wall; how much creative license does the artist have; we should have a meeting with Marie
 - Arlene: did research and Joseph gave her a list of places to paint; commission does not have a budget; Powwow was willing to work with us but we do not have budget; \$100,000 for 5 walls
 - Stephen: will get dimensions of the War Memorial Building; will get the list of buildings from Arlene
- Muralist search/candidate
 - Arlene has artists; we should pay the artist; Eric, Jessica, and Amir
 - Nancy: War Memorial Gym would be great for a sports-focused mural; Arlene: will tie in the first exhibit Commission did
- Budget
 - Serramonte Mall has budget to pay for paint and the muralist
 - Budget depends on the dimensions of the wall, amount of paint, insurance, and artist fees
- Grants – San Mateo County or another alternative
 - Stephen: Measure K - we can try to apply for that fund
 - We need an itemized budget and other funding sources to supplement what we get from the funds
- Sponsorship – Entities
 - Liz: will look for sponsors; aim for \$100,000

- Next steps:
 - Liz will create a proposal
 - Will have it done by the end of March

ARTIST BACKGROUND

FELICITA NORRIS

MY PAINTINGS BEGIN AS REACTIONS TO PERSONAL EXPERIENCES, ALTHOUGH THE IMAGES AND THEMES REPRESENTED ARE NOT STRICTLY AUTOBIOGRAPHICAL. BY USING EVERYDAY SITUATIONS, SYMBOLS, SPACES AND OBJECTS, INCLUDING THE HUMAN FIGURE, I HOPE TO REVEAL THE COMPLEXITIES OF THE FAMILIAR TO BOTH PROMPT CURIOSITY, AND TO DRAW THE VIEWER INWARD. EMPLOYING A SERIES OF MULTIMEDIA PROCESSES, THE PAINTINGS BECOME A STAGE FOR FIGURES AND OBJECTS IN CONFINED SPACES, DEPICTING, AT TIMES, UNSETTLING IMAGES THAT RESPOND TO SOCIAL CONSTRUCTIONS, INSTITUTIONS AND POLITICS.
