**Public Participation:**

In the body of the email, include the item number and/or title of the item as well as your comments. All comments received by 4:00 pm will be emailed to the Small Business Commission members prior to the meeting. Those comments received after 4:00 pm will be added to the record and shared with the Small Business Commission members following the meeting.

To speak at the meeting, you must register to join via Zoom. The City requests that you complete your registration by 5:00pm on the meeting date. After registering, you will receive a confirmation email containing instructions on how to join the meeting, including a unique link. Your address and email will not be disclosed to the public. Public comment is limited to two minutes maximum.

To register to speak at the meeting via Zoom, visit [bit.ly/june10zoomreg](http://bit.ly/june10zoomreg). You must familiarize yourself with Zoom prior to joining the meeting. When you would like to speak on an item during the public comment portion of the meeting, you will need to use the "raise hand" feature in Zoom. The City will not be providing technical support.

**SMALL BUSINESS COMMISSION ROLES & DUTIES SUMMARY**

The City Council created the Small Business Commission to better serve, and to establish a greater connection with, the City's small business community. Appointed Commissioners serve in an advisory capacity at the pleasure of the City Council. Generally, Commissioners advise the City Council in fostering, promoting, and retaining small businesses in the City.



Specific duties of Small Business Commissioners include the following:

- A. Advise the City Council on all matters affecting the small business community within the City and to advise and assist other City boards and commissions as it pertains to small businesses;
- B. Encourage strategies that support the functioning of small businesses in the City;
- C. Foster programs that promote and celebrate the small business community;
- D. Support the formation of new businesses within the City;
- E. Provide local businesses with economic, demographic, and land-use related analytics to eliminate information gaps in the small business community;
- F. Create a collaborative environment for local businesses to voice their desires, concerns, and hopes in connection with business ownership/management in the City;
- G. Establish an effective liaison between the City, local businesses, and small business groups;
- H. Undertake and carry-out all functions reasonably necessary to accomplish the objectives and to discharge the functions of the commission;
- I. Exercise such other functions as may be prescribed by the City Council.
