When I mention “the unit block” of a street, this means the incident occurred at an address anywhere between 1 and 99 of the street.

Robberies

There were eight robberies during the past two weeks.

On Monday, 11-13-23, at approximately 10:30 p.m., a victim stated he parked and exited his vehicle on **Saint Francis Boulevard** and **Belhaven Avenue**. When he went to the rear of the vehicle to remove his duffel bag, two male suspects assaulted him, causing him to fall to the ground. The suspects then took his wallet containing \$300, a CA driver’s license, and an ID from the duffel bag. The suspect also took a \$200 gold chain from his neck. The victim described the suspects as 28-30 years old and wearing black clothing.

On Tuesday, 11-14-23, at approximately 7:01 p.m., officers were dispatched to **Lucky Supermarket** on a report of two suspects who stole \$400 to \$500 worth of soap. An employee stated that both suspects concealed soap in their backpacks. When the employee asked them to return the merchandise, one of the suspects reached into his pants pocket and told her he had a gun. The second suspect said, “If you touch me, I’ll touch you back.” Both suspects fled the store in opposite directions with the stolen soap. The first suspect was located on the 6900 block of Mission Street. A backpack with approximately \$100 worth of soap was found across the street. The first suspect, a 23-year-old San Francisco resident, was arrested and booked into jail for robbery and other charges. The second suspect was described as a Black male, 6’0” tall, 25-30 years old, carrying a black backpack, and wearing a white tee shirt and black sweatpants. This investigation is continuing.

On Saturday, 11-18-23, at approximately 6:55 p.m., officers were dispatched to **Nordstrom Rack** on a report of a robbery. The loss prevention officer said a suspect entered the store, selected \$250 worth of boots and jackets, and placed the items in a plastic bag. The suspect left the store without paying for the merchandise.

When the loss prevention officer grabbed the bag of merchandise, the suspect ripped the bag away and fled on foot. The loss prevention officer described the suspect as a Hispanic male wearing an orange-yellow puffer jacket.

On Tuesday, 11-21-23, at approximately 1:30 p.m., a suspect approached a victim in the area of 500 **Westlake Center** and forced a victim to withdraw \$10,600 from his bank accounts. Later in the day, the suspect, a 22-year-old Florida resident, was arrested and booked into jail for robbery and another offense.

On Wednesday, 11-22-23, at approximately 10:20 p.m., an officer was dispatched to **Safeway** on a report of a robbery. Two suspects entered the store. The security guard said a suspect pushed a shopping cart full of merchandise worth approximately \$345 past registers toward the exit doors. The security guard told the suspect to return and pay for the merchandise. The suspect told the security guard to get out of the way. The security guard proceeded to turn the shopping cart over. The suspect picked up a box of canned soda and struck the security guard in the face. The suspect ran out of the store and got into a white sedan. The second suspect exited Safeway and entered the vehicle. The vehicle fled out of the parking lot. The suspect that threw the soda was described as a Black female, 30 years old, 5'7" tall, 150 pounds, with braids tied in a bun, and wearing a black sweatshirt and purse. The second suspect was described as a Black female. This investigation is continuing.

On Friday, 11-24-23, at approximately 5:54 p.m., an officer was dispatched to **Lucky Supermarket** on a report of a shoplift. It was learned that the day before, on 11-23-23, the same suspect stole approximately \$70 worth of detergent. When an employee attempted to retrieve the detergent, the suspect reached into his bag and concealed his hand. The employee believed the suspect had a weapon inside the bag. The suspect fled the store and headed northbound on Mission Street. On 11-24-23, the suspect took \$150 worth of groceries and merchandise. After the suspect exited the store, he was stopped by officers. The suspect, a 28-year-old Oakland resident, was arrested for both incidents, the shoplift and robbery, and booked into jail.

On Saturday, 11-25-23, at approximately 3:25 p.m., officers were dispatched to **Macy's** on a report of a shoplifter. A loss prevention officer stated that the suspect entered the store, selected a denim jacket, concealed it in a luggage bag, and exited the store without paying. Outside the store, while another loss prevention officer was trying to detain the suspect, the suspect pushed the loss prevention officer. Loss prevention officers recovered approximately \$800 worth of stolen merchandise. The suspect, a 50-year-old Daly City resident, was arrested and booked into jail for robbery.

On Sunday, 11-26-23, at approximately 4:57 p.m., officers were dispatched to **Target** at the **Westlake Shopping Center** on a report of a robbery. An asset protection specialist said the suspect entered the store, proceeded directly to the hardware section, concealed approximately \$120 worth of items into his black hoodie, and exited the store without paying. Once outside the store, the suspect pushed another asset protection specialist and walked away with the stolen merchandise. Shortly after, an officer located the suspect sitting at the bus stop on Lake Merced Boulevard and Belmar Avenue. The suspect, a 40-year-old San Francisco resident, was arrested and booked into jail for robbery and outstanding warrants.

Residential Burglaries

There were no residential burglaries during the past two weeks.

Commercial Burglaries

There were no commercial burglaries during the past two weeks.

Vehicle Burglaries

There were five vehicle burglaries during the past two weeks.

- Parking lot of **Serramonte Shopping Center**—plumbing and sewer power tools were taken from a 2019 **Ford Transit 350HD**. The suspect made entry into the utility box equipped on the back via punch to the locks on the doors. Occurred on 11-16-23 at approximately 10:27 a.m. The suspect vehicle is a white Jeep Grand Cherokee. The suspect was described as a Hispanic male wearing a face mask, white hat, and black and white hooded sweatshirt.
- Parking garage on the 1800 block of **Junipero Serra Boulevard**—clothing and a jumper car kit were taken from a 2022 **Kia Sorento**. The rear window was shattered. Occurred between an unknown time on 11-17-23 and 12:44 a.m. on 11-18-23.
- Parking garage on the 1800 block of **Junipero Serra Boulevard**—nothing was taken from a 2015 **Land Rover Evoque**. The rear window was shattered. Occurred between 9:15 p.m. on 11-17-23 and 12:35 a.m. on 11-18-23.
- Parking garage on the 1800 block of **Junipero Serra Boulevard**—a backpack and MacBook Air were taken from a 2018 **Lexus IS350**. The rear passenger side window was smashed. Occurred between 10:30 p.m. on 11-17-23 and 12:45 a.m. on 11-18-23.
- Unit block of **Midway Drive**—a black tool bag with two Milwaukee drills and a gym bag containing an Apple watch and a pair of Nike Air Jordan shoes were taken from a 2021 **Mercedes-Benz GLA 250**. The rear passenger window was shattered. Occurred on 11-21-23 at approximately 6:26 p.m. The victim said there were three suspects and described them as Hispanic male juveniles.

Stolen Vehicles

There were nine stolen vehicles and one attempted stolen vehicle during the past two weeks. Six vehicles were recovered.

- **Mission Street** and **Goethe Street**—a 2007 **Infiniti G35**. Occurred between 10:00 p.m. on 11-20-23 and 3:30 a.m. on 11-21-23. **Recovered by Oakland PD on 11-22-23.
- **Hickey Boulevard** and **Callan Boulevard**—a 2011 **Infiniti G37**. Occurred between 7:30 p.m. on 11-23-23 and 8:50 a.m. on 11-24-23.
- 100 block of **Los Olivos Avenue**—a 2008 **Infiniti G35**. Occurred between 9:00 a.m. on 11-25-23 and 11:00 a.m. on 11-26-23.

- Unit block of **Calgary Street**—a 2019 **Chevrolet Camaro**. Occurred between 5:30 p.m. on 11-26-23 and 7:00 a.m. on 11-27-23.
- 200 block of **Whittier Street**—an attempted theft of a 2017 **Infiniti Q50**. Occurred on 11-25-23 at approximately 4:31 a.m. The suspect vehicle is a yellow SUV occupied with four subjects. One of the suspects was described as a male, 5'8" tall, medium build, wearing black clothing with a ski mask.
